Introductory note

This introductory note does not form a part of the notice

Under the Environmental Permitting (England & Wales) Regulations 2016 (schedule 5, part 1, paragraph 19) a variation may comprise a consolidated permit reflecting the variations and a notice specifying the variations included in that consolidated permit.

Schedule 1 of the notice specifies the conditions that have been varied and schedule 2 comprises a consolidated permit which reflects the variations being made. All the conditions of the permit have been varied and are subject to the right of appeal.

This notice is to vary the permit held by the operator from a Standard Rules permit “SR2015 No15: WEEE authorised treatment facility (ATF) excluding ozone-depleting substances”, to a bespoke permit in order to add a small scale bio-leaching process to the activities covered by the permit. This process is a form of treatment to recover precious and rare earth metals from printed circuit boards.

The schedules specify the changes made to the permit.

We consider that in reaching our decision to vary the permit we have taken into account all relevant considerations and legal requirements. We are satisfied that the permit will ensure that a high level of protection is provided for the environment and human health and that the activities will not give rise to any significant pollution of the environment or harm to human health.

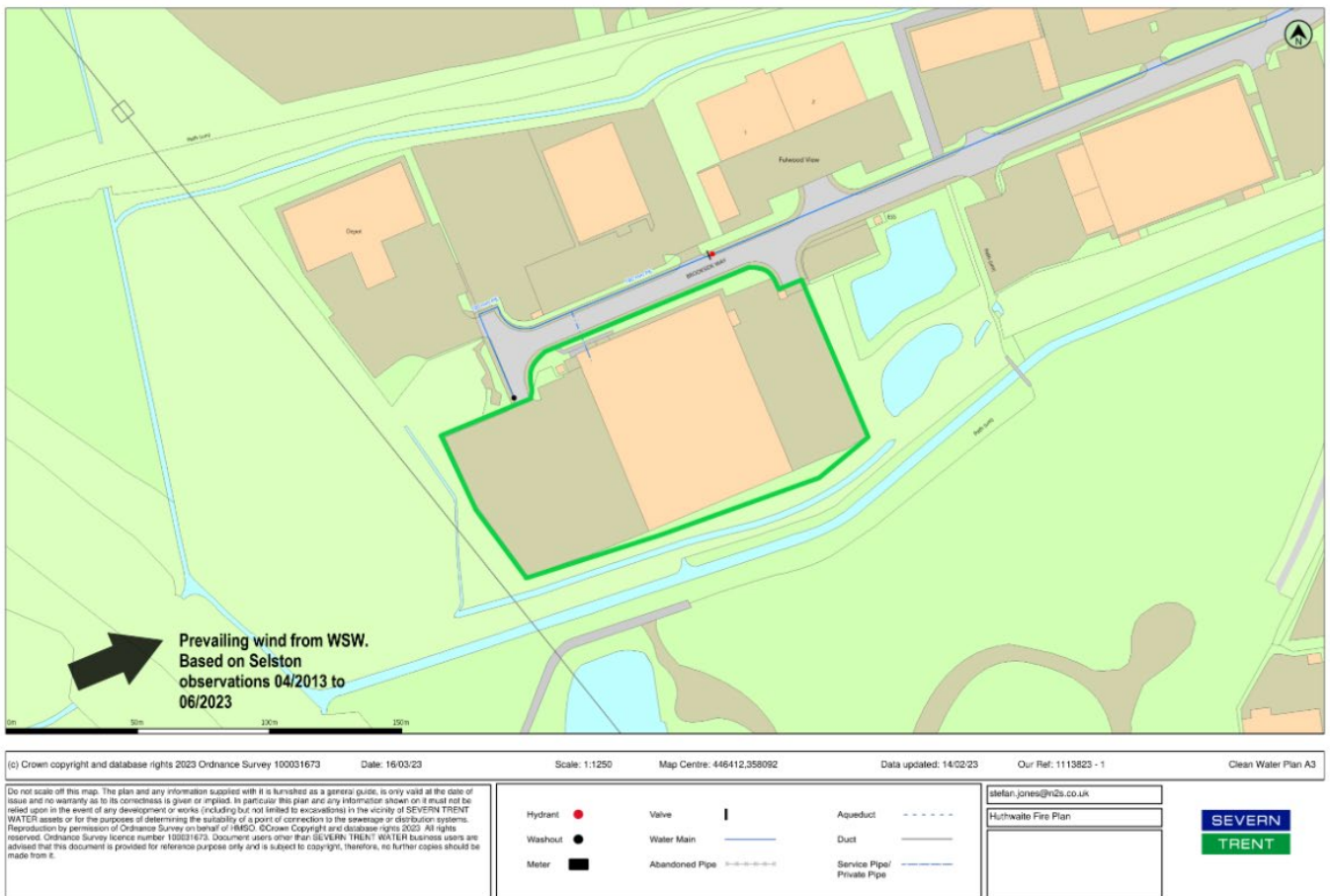
